

## **Kalbarri House For Rent.**

The Club has a house in Kalbarri. The house is situated close to the river, beaches and town. It has two bedrooms and will sleep up to eight (max) in 1 double bed and 3 bunks, has reverse cycle air conditioning and ceiling fans to keep you cool in the summer months. Users need to bring their own linen, blankets and towels, tea towels, etc.

It has a radio and television, stove with oven, microwave oven, crockery and cutlery and all cooking utensils, fridge and freezer. It does not have a washing machine, but there is a laundromat in town. Outside has a fish cleaning facility and a full width verandah. Rates are:-

Public:- Off season \$250 per week, On season \$390 per week } all plus \$50

Club Members:- Off season \$160 per week, On Season \$210 per week } deposit / bond.

Club Members:- Short term \$45 for one night, \$40 per night for two or more nights} plus \$55.00 cleaning

Bookings taken for the school holidays go from Saturday to Saturday (leaving by 10am). Outside of school holidays it does not matter. The club has decided that cleaning will need to be paid for and is \$55.00 extra on the rates above for future new bookings. The club is now being charged GST on the cleaning.

Check in time is 1pm. Check out time is 10am. Keys can be picked up from Ray White, Shop 1, Kalbarri Arcade. If people arrive after hours, they leave a note on the door of their office with a map of how to get to the house and telling them where the key will be.

### **September 2004 Recfishwest Board Meeting Report.**

Recfishwest and AAA attended a Workshop on Bioregional Marine Planning in Perth on 31 August. The majority of organisations attending had serious problems with the process and had voiced very strong objections.

Recfishwest and the Cockburn Council will compile a list of shoreline areas in Cockburn sound where people are legally allowed to go and see if the access is actually available.

Recfishwest has had detailed but informal discussions with the Liberal Shadow Minister for Fisheries about CALM and Marine Parks planning issues, issues, funding, Rous Head ramp, Integrated Fisheries management, etc.

RFW had a breakfast meeting with the new Integrated Fisheries Manager Greg Paust and Peter Millington from Department of Fisheries. Integrated Advisory Panel is expected to be announced 1 October. Recfishwest is expected to play a large part in getting and assessing public comments on the recreational side of Integrated Fisheries Management proposals. A clear process is needed. Early task for Greg is to advise the Govt on funding to RFW for Integrated Fisheries Management.

Harry Vosper (WA Trout and Freshwater Fishing Association) and Frank Prokop to prepare a proposal for the coming marron season

Ian Curnow Recreational Fisheries Manager wants regular meetings and discussions with Recfishwest.

Recfishwest have put in detailed comments on fishing parts of the massive South Coast, South West Region and Northern Agricultural Region Strategies for Natural Resource Management process. RFW will write to the Federal Minister about the lack of consultation and coordination.

No further meetings had been held about Wetfish Review. However a report from the Access Panel was expected in August, due soon but no details. Election timing may be an issue.

There was a lot of discussion about RFW withdrawing from the Marine Parks Planning process because it was taking up so much time, up to 70%, and didn't seem to be getting very far. It was agreed that it was necessary to stay involved and raise the level to recognise the political nature of some decisions.

A number of actions are proposed over the Ningaloo Marine Park. Some recreational anglers from Exmouth will be manning a display at the Perth Royal Show.

Port Catherine/Coogee Development. RFW has send a letter suggesting that the \$1.5M should either (a) go to a boating facility south of the river on condition that the land around the facility is vested in DPI and not CALM, or (b) be used towards constructing a new boat ramp facility at Rous Head.

Cockburn Sound Pink Snapper management. Department of Fisheries will issue a discussion paper about proposals for protection of spawning pink snapper in the Cockburn Sound, compliance issues with ramps in Cockburn Sound, and possibility of reopening shore based fishing for snapper.

South Coast recreational fishing proposals public meetings in Walpole, Albany and Esperance had not been very successful, according to some reports. RFW to request a metropolitan public meeting to discuss both South Coast and Pilbara/Kimberley proposals.

RFW has written to the Premier and Minister for the Environment requesting that summaries of public submissions are made available to the public before the implementation of the Ningaloo Plan.

Terry Fuller reported on the proposed presentations to the Marine Parks and Reserves Authority for the proposed Capes Marine Park.

Mark Pagano reported on the 25 August meeting of the Focus Group for the proposed Walpole/Nornalup Inlets Marine Park. No sanctuary zones are proposed.

The recreation zones in the Jurien Bay was to be raised with Minister Edwards at the next scheduled meeting, but the meeting hasn't taken place. RFW to write asking for progress.

Reports about the super trawler Veronica had caused alarm. The Federal Minister has issued a statement that the trawler will not be allowed to operate in Australian waters.

### **Random thoughts & suggestions about what to do / how to do it.**

Over the years I've seen many people react to something and say "you (or they) orta do....., etc." To explain to them, I've written out reasons why I think some things or ways to do things are good, and why some are not so good. Some ways are almost guaranteed to cause hassles and make it hard to get what you want.

These thoughts and suggestions are based on what works for me and what doesn't work as well for me, or what goes smoothly and what goes less smoothly. Of course, nothing is ever **all good** or **all bad**, because there are always shades in between. And you might think differently.

This goes to the very heart of those three deceptively simple questions as published on page 20 in the September Reel Talk. If what you are doing won't achieve what you **say** you want to achieve, why the heck are you doing it? And if you **say** one thing but actually **mean** something else, well you haven't been honest to yourself with the answers, have you?.

Here is a collection of some of these random thoughts and suggestions about what to do and how to do it and why to do it one way and not another way. Please forgive the inconsistent use of the words "we", "he", "you", "they" "people" etc.

These things are timeless, and there's nothing much new in here that you won't find elsewhere in some form or other.

So why is this in this Reel Talk? What's the relevance to the Surf Casting and Angling Club at present? I'll leave that for you to work out.

**Message or messenger?.** If you don't like the message, do something. But first make sure you don't misunderstand the message. Read it and think about it - don't just react to it.

If the message fits you, then accept it and deal with it; but don't just "shoot the messenger". If the message is abusive, then deal with the abuse, but still don't forget any message that might be in there despite the poor way it is presented.

**Allies or Enemies?** Just because someone is working for the "other side" doesn't mean you have to fight them all the time, or disagree with everything they do and say.

Creating and having a real "enemy" on the other side who doesn't like you and who'll actively oppose you just on principle - well who needs that?

You can respect what he thinks and does and get respect for what you think and do even though you don't agree on the details.

Having an ally on the other side can open up great insights into how the other side works. It can give a much better understanding of what is really important to them, as distinct from what is in their ambit claims, and what you have in common with them.

Working together might mean that each side might gain a little or a lot, often by only giving up a little, but sometimes not giving up anything. Then the end result is very much better than it would be if each side just resisted and fought the other.

Some other people will criticise cooperation and working together like this, and use derogatory terms like "sleeping with the enemy". The answer to that is to always act with integrity so that there is nothing wrong with what you do.

**Cooperation or confrontation?** We can get more done by cooperation than by confrontation. Play the issue and not the man. Give credit where it is deserved. Criticise what's has been done, not the person who did it. Save that for much, much later when and only if rarely it might be the right thing to do.

Like them or not, some people or groups have influence, contacts and knowledge, and/or are recognised as "the" group that someone else will listen to. Who loses if we refuse to work with them? Use them where we need to. Do our own thing where that works. If something doesn't work, think about it try something else.

**Integrity.** Put simply, that means "Doing the right thing, no matter what". If there is anyone who needs "Integrity" explained more to them, well....

**Respect.** Yep, we all deserve and expect to be treated with respect at all times. People can demand that type of respect and no one can argue much with that.

But there's another type of "respect" too. It's what people get or lose from a whole range of things like how they treat other people, their judgement, their abilities, their hard work, their compassion, how they handle difficulties, how they use their abilities, etc, etc.

They earn that respect, but it so easy to lose and very hard to get back once it has been lost. No one can just demand that sort of respect. In fact if people do demand it, that just shows they probably don't deserve it.

**Know when to keep confidences.** Sometimes you'll be told things in confidence or find out things which shouldn't be made public - maybe because it's too early in some process. If people know they can trust you and trust your judgment, then lots more will be open to you. If you can't keep things in confidence, you will very quickly stop getting told or shown them.

If you are pressed to reveal things, you can always say "Yes, I know some things but they are in confidence for reason xx, so I'm not able to pass them on." If anyone else has a problem with that statement, then that's their problem, not yours.

**The truth.** The truth stands - but just being true is not enough to justify it. Some part-truths can be just as bad as lies if they mislead and you know that they will mislead. If you don't ever tell lies and misleading part-truths, then you don't have to try to remember which one you told to which person, so you won't get caught out later. Then you don't have to have a good memory for these sorts of things.

It's a lot easier to always tell the truth, or enough of it not to mislead, or if that doesn't suit the purpose, just say nothing. Remember the old saying "you can fool all the people some of the time, you can fool some of the people all of the time, but you can't fool all of the people all of the time."

**Show your judgment.** Know yourself, because others will soon find out what you are capable of. Don't rush in to things. Be diplomatic. Listen long. Very few things are SO urgent that they have to be done right now. Prepare something and then put it aside for a day or two before looking at it again and before sending it off.

If in doubt, think long and hard and get advice from someone you respect for their experience and judgement. If you don't have any doubts despite having spent only a short time on something, then question your own judgement or knowledge.

**Do they know enough to know what they don't know?** Or do you? If people don't know enough, they can think that they do know it all, simply because they don't realise the limits of what they do know. You'll recognise some of these people when they come on strong and then show the limits of their knowledge.

There's so much to know, and we can't all know about everything. But we can all ask questions, we can all get other people's opinions and ideas and knowledge, we can all do some homework and get informed before we start. "Better to remain silent and be thought a fool, then open the mouth and prove it beyond all doubt."

**Two sorts of provocation.** Words can be provocative where the provocation is **positive** and will get people fired up and moving to come up with an answer.

Some words can be provocative where the provocation is **negative**, will just get some people's backs up, and they will get into "shoot the messenger" mode and the whole thing degenerates into time wasting and "shoot the messenger" arguments, and any good bits in the message are lost.

This happens where people might have used reasonable, correct or accurate statements, but they have said or written them in ways which are or can be misunderstood or misrepresented. Yes, sometimes people simply don't read or hear what was actually said. You either work to stop that from happening, or you have to deal with all the hassles.....

Of course, deciding what provocation is positive or mildly negative is a matter of opinion, judgement, knowledge and experience. Really negative stuff is so obvious. Be prepared for things to go badly wrong if the difference is ignored. Do you want it to go wrong.? More importantly, do the other people involved want the hassles of it going wrong? Back to asking the three simple questions.

**Infighting.** The other side of any issue love to see their opponents fighting and arguing among themselves instead of cooperating, because that shifts the attention away from them and the **real** issues which should be being handled.

**Good work, bad work.** Just because one part of an organisation doesn't do the right thing, in someone's experience or opinion, doesn't mean the whole organisation and all of its work is the same. Many organisations have both great people and no-hopers, great work, so-so work and bad work.

But if any one is to blame, maybe blame the Government or upper management for cutting staff until there just aren't enough people to do the job. Then the workers can't see any end to the pressure or the work and get burnt out or give up. Been there, seen that, done that.

**Weight of numbers, or Weight of Argument?** The public consultations about all sorts of issues attract all sorts of responses. We'd like to think that a few well reasoned submissions supported with relevant facts

and issues will be given more weight than a lot of emotive responses, particularly if they are based on wrong information or are just collected from people at shopping centres, etc.

We'd like to think that it's not simply a numbers game. Reality is:- it all depends. An organisation or person which acts with integrity will treat arguments and numbers on their merits. Unfortunately, Governments often just count numbers when election results are important to them. Use that whenever you can.

**Pressure and lobbying.** Government and organisations will bow to the right pressure. But sometimes Government and organisations will ignore all protests or pressure, no matter what is done. Work out the difference and use the effective ways and don't waste time and effort on the other ones. That doesn't mean not pushing some topics, just work out the best way to do it.

**Funding and people.** If you ask for more money or more people to do something, we have little chance of getting it. Instead find out what's there now and how it's being used. Then ask to change how the money is spent or how people's time is used to get what we want, and we have a better chance.

**Chip away.** It's often easier to get several small changes one at a time rather get than the whole set all at once. The whole set frightens some people.

**The media.** Don't believe everything you read or see in the media. Media should be there to report facts, but they often now select and report things in a way which will stir up controversy. It's either deliberate or accidental, you be the judge.

Their main aim seems to be to increase their readership/watchers/listeners. They don't seem much interested in anything else. Issues quickly disappear out of the media if it suits them, or isn't controversial. Use media contacts to keep issues alive.

**People acting like Politicians.** *Yes Minister* and *Yes Prime Minister* TV shows are a great insight into how to handle politicians or people when they are acting like politicians. Funny but so true sometimes.

**Putting a case.** Don't overstate the case or we risk getting proved wrong. Opponents will ignore all the good points and attack the weak point in a case, media might pick that up and that can work against getting what we want. Don't volunteer details which can be used against our case unless those are very important to the case.

Don't make a statement unless we're sure of the facts. Instead ask a question to find out. Then quote and list the sources of all information or "facts" used.

**Repeating Things.** Just saying things many times, or saying the same things more forcefully doesn't make them right. If the case is weak, it's dangerous and a waste of time to use that repetition technique on intelligent and informed people.

But it is a technique used very successfully at times to passive or one way audiences, especially in the media. If people see the same things in different places, some will think it must be right, mustn't it? So challenge and put the alternatives in as many places as you can so that many people get to see them.

**Reviewing.** When commenting on proposals, look for inconsistencies, contradictions, things which aren't logical, don't fit with another fact or claim, seem to be based on somebody's assumption about what's wanted or needed, when in fact what's wanted or needed can be completely different.

Ask direct questions which can't be avoided. If they are avoided, follow up straight away. Don't let them off the hook.

**The "antis."** Remember duck shooting in Australia?. Remember how there used to be fox hunting in England? Remember the rabid antis targeting the people who were doing those lawful activities, the media campaigns, etc until it got all too much and the governments got tired of it and banned the sports.

You might think duck shooting and fox hunting are completely different to recreational fishing, but the anti fishing lobby doesn't think that and doesn't care what you or anyone else thinks. You might be all very peaceful and law abiding, but the opponents won't be.

Some people might say "bring them on, we'll fight them". But those antis had a lot of vocal and physical support, some of which was absolutely ruthless (and lawless), and will do anything and keep doing it for as long as it takes to get what they want.

Do you think you can organise enough of WA's mostly apathetic recreational anglers to fight the long fight directly against the antis. What if the antis do it at a National level in another State. Even if you can organise some people, there is a good chance you will lose. See the bit "antis will keep doing it for as long as it takes....."

The best you can hope for is that the antis will be too busy with other things higher on their list to get around to targeting fishing. Keep a low profile so that fishing doesn't become more important to them.

**Who wins, who loses?** Remember how the Court Liberal Government handled the greenies when they were protesting about wood chipping in the South West. The Government changed the camping laws so that you can't sleep in your vehicle, can't camp in so many places, etc, etc. so that's stopped overnight camping or even sleeping in our vehicle alongside our fishing rods for all us recreational anglers and a lot of other outdoor types. Thanks a lot, who lost most in that little campaign?.

Sure, that probably helped the Liberals lose the next election, and we got a Government elected with "Save the old growth forests" as part of their platform, but we've still got those draconian camping laws. Easy to get rules brought in, almost impossible to get them relaxed.

**Easy, just get the recreational anglers to rally and protest.** Do you think you can get enough support to make recreational fishing a real election issue. I think yes, if you use the figure of 600,000 odd recreational anglers, but only while that figure isn't seriously challenged.

But turn it into an issue where WA's mostly apathetic recreational anglers have to front up to lots of demonstrations (not just one) and the number will be a lot, lot lower and might prove that the Government just doesn't have to worry about us as an issue electorally or the number of votes at risk.

You must get and keep the support of the public. There are many problems here, but much of the public will not support anything which is unfair, or is portrayed in the media as unfair. The media doesn't always tell the truth, truth as in the whole story, not selected bits which suit their case.

The government and antis have lots of resources and influence to run a media campaign. Just look at old growth forests and Ningaloo, and a hundred other issues which have been decided by part truths, mistruths and plain old deception, not forgetting repeating it so many times and in so many places that some people start to believe it. The government is now saying "we have saved Ningaloo!!" Saved all 260 km? From what?

**Play the man or play the ball?** If you attack the man, not the issue, you will lose or risk losing lots of public support. Attacking the issue can be just as effective, and that can be ruthless to show all the problems. It should focus on what has or has not been done, but should not be a personal attack. If you don't have a good case to put about the issue, how do you expect to convince the public to support you?.

If you attack the man, what sort of cooperation from him can you expect in future? Beware of winning on one issue and losing out big time for the rest of the time he is in that position of power or influence and you still need to get his cooperation on some things. See Allies or Enemies?

**Don't like the rules?.** Then work on the people or organisations who make or who can change the rules.

Don't blame people who are working within the rules - they don't make the rules. If they are working within the rules, then the pressure should go on the Minister or Government or the company to change the rules.

If you target the commercial fishermen going about their business within the rules, you will get support from some people, but what about support from the majority of the public? The fisherman don't make the rules. If they are breaking the rules, then they are fair game, but make very sure of your facts first.

Heads and staff of Departments are not fair game for personal attacks. If Departments are not working to the rules, then we should demand they apply the rules. If that doesn't work, the pressure should go on the Minister to make them work to the rules.

If it is a matter of how they are interpreting the rules, then write down all the arguments and the issues so that everyone can see what needs to be done. Facts not opinions.

**Don't like what they are doing?** The Government is responsible. Heads of the government departments are usually just carrying out government policy, or are limited by what government gives them to work with, the laws, the regulations, the money, the numbers of people, etc. The government can direct them to do it differently or can change the laws/rules.

The workers at many levels are just doing the job they are employed and paid to do. Don't blame the workers for the job they have to do. Remember they need a job to live and feed their families. You **can** comment on how they do it if they act unreasonably or don't do the job properly.

**Questions.** Never ask a question or force an answer if you already know and/or might not like the answer. Find a different way of handling it. Or you might regret you asked that question.

Know the other side and what he is likely to do, how he will react. Be careful of starting a fight you will lose.

Be careful of winning on a few issues, but losing out overall.

**Fireman or Fire Prevention Officer?** Who's most valued? Who is the first to get cut back when someone is trying to "save" money or cut staff? Who is always welcomed when the fire's blazing and disaster looms? Who often doesn't get any credit when there weren't any fires this week/month/year? Who is seen as just a pedantic pain in the backside with fire prevention regulations and rules stopping people from doing risky things they think they should be able to do? See "do they know enough to know....."

So if you want to be valued by people who don't think too hard, then become a "fix it" person who is good at putting out the fires, mending things, fixing up the hassles and getting people out of trouble. But the really valuable person is the one who works in the background and **stops unwanted things from ever happening, so the fixes aren't needed.**

When I do small edits to people's articles, I usually give them a courtesy copy of what I propose to publish.

As Reel Talk Editor, I might receive articles which I am not prepared to print in the form as first presented, because of the possible and usually completely unnecessary impact on the Club.

Articles can be provocative where the provocation will get people moving to come up with an answer. Or they can be provocative where the provocation will get some people's backs up, and they will get into "shoot the messenger" mode.

When I think an article needs a lot of changes, I offer to cooperate and help work through it together. This is to try to come up with a good article which is still completely acceptable to the original author and achieve what he says he wants (if that is appropriate - another decision!).

But what if we can't agree on what should be in and not be in the article? When does that working together have no chance of resolving it and editorial responsibility take over? That's when the editorial decisions get hard. But they have to be made.

Which decision? I have to try to keep personal opinions out of this editing and try to edit in the interests of the club. Other people can judge if that has been successful or not.

In the past, some things have been let go through despite having there being concerns about them. Then people like the President or Secretary or one of the Organisers have been forced to do a lot of unnecessary and extra and urgent work to smooth things over and fix up the mess which has been left.

Getting caught once is learning, getting caught again is careless or stupid.

We have all seen various public meetings and media articles degenerate into "waste of time" and "shoot the messenger" arguments. This happens even where people might have used reasonable, correct or accurate statements, but they have said or written them in ways which are or can be misunderstood or misrepresented. Yes, sometimes people simply don't read or hear what was actually said, but that's life and we need to deal with it.

Then the whole thing gets hijacked by the arguments and the original important points get lost. These are just a waste of everyone's time. Most of this is avoidable if you have "been there before" and don't want to go back and if you think about it. You either work to stop that from happening, or you have to deal with that and all the hassles.....

## **Field Day Garden Island, 11/12 August, 1962**

Reprinted from the September 1962 Reel Talk.

Weather conditions:- North-East winds, varying during the night, eventually turning towards the East in the morning. Beaches heavily weeded North and South. The only beach area comparatively free of weed, but which eventually deteriorated as the evening progressed was the area down from the Guns, but this area with the fishermen's curse (weed) and the turbulent sea made angling very hazardous, though a few of our more hardy members stopped on and fished throughout the night.

Once again the Northern beaches proved to be the popular spot, for quite a few of the lads fished there with varying success. The Mulloway did appear, though they were slow in taking the Mulies and weren't as available as in the last few outings.

27 members and 2 visitors attended the venue which was quite a good roll-up considering the inclement weather. For a while there I thought that the field day would be a wash-out but on the whole the weather was considerably better than the previous two outings to the Island. With the weather improving, let's see bigger turn-ups at field days from now on. For I think that we all enjoy themselves, even if we don't catch too many of those wily fellows of the deep.

The first boat to the Island carried only ten of our members as passengers, with the remainder coming over by the afternoon boat. The early arrivals were keen to get ashore and endeavour to find the hot spots are places that were preconceived as being "the place for the week-end"

"Snow" Tate and Alan Livesey headed for their favourite spot down South, as they were not very impressed by the North end, after the last venue when they really ran into rough weather and not too many fish. Both Alan and "Snow" turned in quite good bags of fish at the weigh-in which bought forth envious sighs by members who had not been as successful.

Bob "Lucky" Lilly, Jerry Windus and young Doug Clegg walked up the road to the Gun, while Ron Shirley and myself decided to do a tour along the beaches looking for a good channel or at least clear water. We found all the bays completely blanketed with weed and so utterly unfishable, so we kept walking until we arrived just below the Gun and picked out a likely looking channel and believe it or not clear water - which looked very inviting.

Farther up the beach Bob Lilly and company were setting up camp and were collecting firewood as prevention against a cold night. Bob strolled down and suggested we change spots and join him, but we elected to stay where we were - which was a good decision, for later on the Tailor and Mulloway came on the bite - not furiously - but enough to keep us interested. Bob Lilly landed a nice one of 7¾ lb next morning which took off the heaviest scale fish award. I did hear that that Mulloway when Bob cleaned it contained about six Mulies, lucky for Bob the Mulloway had been living well.

Later in the afternoon the second boat party arrived, and it wasn't long at all before they were looking the place over and picking the likely positions to fish from. One minute there were four or five lonely bods on half a mile of, beach, next minute presto! the place was alive with lads thrashing sinkers and bait into the blue.

Bob Tucker and Tom Smith joined our party, though Bob Tichbon and Hugh Gregory said hullo and then went on up the beach, between Bob Lilly and Ron Kildahl and George Greenham. It was good to see Hugh along again, and by all accounts he is going to be a regular. It is indeed good to see all these lads getting together and fishing the one beach, causing no trouble to one another, giving each other advice, saying hullo and offering help whenever it is needed - makes you realise just how good it is to belong to a Club like this and know so many fine chaps who all have the one interest in common - angling.

George Greenham started the ball rolling by beaching a nice Mulloway at 4.01 p.m. which gave the impression that the game was really going to be on. Then Ron McQueen, further down the beach was observed working a fish in through the surf a little later on, which also proved to be a Mulloway. Then the game was on. First myself, then Ron Shirley were into one each and with a roar that could be heard over on the mainland from president Bob left nothing to the imagination that he was onto one.

Nick and Charlie Crouch must have heard the din for they put in an appearance and settled in to some serious fishing. Bob caught another Mulloway and about the same time I was fortunate also and Ron Shirley pulled in two nice Tailor - but from then on it started to slow down considerably with just the occasional Mulloway being caught and the weed getting worse. Later in the afternoon Norm Giles also appeared having walked from the Rifle Range looking for a clear area to fish. Quite a stroll. Norm tried with all his skill - but to no avail. It evidently wasn't Norm's turn, though as a rule if there is fish there Norm will find them.

The surf was quite heavy and on one occasion when Bob Tucker turned his back for a second to attend to his rig, a wave almost carried him away, covering his rod and reel with seawater and sand, though he carried on regardless. Tom Smith also had his problems and I thought for a while he was adopting a new style of casting when he threw his rod into the water, but I consequently found out it had slipped out of his hand. All we could see of Tom was his head and shoulders, the rest was submerged - don't go much on these skin-diver types on field days.

The steep slope also made casting a problem and on one occasion I thought I was going for a swim too as a wave engulfed me to the waist. It was only by digging my feet in and maintaining balance that I didn't go over, but was I wet, just as well I was only wearing shorts. (The way you fish this time of the year Jim I don't think you have any feeling at all. Ed. 1962)

All this time the boys were continuously pulling bundles of weed and behind each angler was a great stack, though they kept at it. Alf Rutland and 'Rocksnapper' Backhouse had been making heavy work of the weed around the corner from us, so they joined our party which were nearly as badly off. 'Rocksnapper' though he prefers to catch 'Rockies' had the misfortune to catch a Tailor which spurred us on with renewed vigor, but eventually we had to knock off because of the weed.

Shortly after 9 o'clock Ron Shirley and myself, with our gear packed, scaled the hill and headed back to base for a snack and a cuppa. Back at the hut the lads reported heavy weed in the South areas. Rifle Range also unfishable. 'Lofty' Griffiths and Alan Livesey had both caught a Salmon but unfortunately before field day time. Bad luck chaps. Most of the lads retired early, ready to do battle with the B- in the morning. Come the dawn and many of the more hardy types left their warm beds and sallied forth, though unfortunately without much success.

I walked up to the Gun position in the morning to observe quite a large group of anglers still plugging on. Charlie Crouch landed a Tailor, which cheered him up. Bob Lilly landed his Mulloway with much rejoicing. Our Victorian visitor, C. Patton had two nice sized Mulloway to his credit and remarked that the surf was

much heavier than he had experienced in the East. Though he said that he had a wow of a time and enjoyed the venue.

Even though the Mulloway and Tailor failed to show in the morning in any great number, it was very pleasant fishing and made one feel really alive. Ron Kildahl appeared blown out as he had fished all night, with George Greenham - it is little wonder. Ron had three nice Tailor to his credit, and George had two Mulloway, these lads deserve a lot more for their efforts, they certainly are keen.

Weigh-In time was quite interesting, as the lads turned up to weigh their fish. Both Alan Livesey and "Snow" Tate had nice bags of Herrings and Skips. Nick Crouch was again to the fore with three Mulloway and a Tailor. Bob Tichbon managed two Mulloway - if he can catch them anyone can. Hal Neil weighed in a 6lb. Mulloway which helped to make him happy. Doug Savage caught two nice Tailor and one Mulloway, though his mate didn't seem to be able to strike the right note.

Though we didn't catch as many fish as we would have liked I am sure that we all enjoyed the venue and are looking forward to the next one which is also at Garden Island.. I would like to see more Juniors along to these venues as well as their Dads and as the weather gets better I expect, that I will - that also applies to Dry Casting days, and I think that it is about time that we saw some of our life members along also. Surely they are still interested in angling and the activities of the Club that they helped along in past years. I know that we would be pleased to see them.

So closed another enjoyable field day, and to all those who helped me on the venue, especially Ian McLennan, go my special thanks for helping at the "Weigh-in". To Ron Shirley and young Doug Clegg go my thanks also for the help that they gave.

To the award winners I would once again like to offer my congratulations, and by way of a change I managed to come into that category myself which only goes to show that everyone has a chance of winning one of the three sections each field day. To those whose luck was in reverse, lets hope that next time it will improve to the positive, and that you will drag off a section.

Our next field day is also at Garden Island, so don't forget to put in for your leave pass real early and be in it. Boat timetable is the same as last month, 9:30am and 2:00 p.m, from Palm Beach jetty. Boat fares 8/- return for adults, 4/- for juniors, sweep 2/-, if you choose to sleep in the hut 5/- and 2/- parking for vehicle owners in shop area. Please try to have correct money which helps to facilitate when collecting. Change can become a problem.

According to dehydration scale a 20lb fish could lose 1lb in weight over a six-hour period, but Bob Lilly had no worries about dehydration with his Mulloway, for it was still kicking when placed on the scales at the weigh-in. You may think well, why write about this, why not that fish that got away or the trip of a lifetime (Dirk Hartog Island was one)? Another time maybe.

Reel Talk October 2004

I started fishing on a river (Stour) which ran through the Throop Fishery just north of Christchurch (Dorset, England). One side of the river flowed past mainly low pasture fields and you fished the opposite side so the river was flowing from right to left. The Water Bailiffs would work the river and cut weed and trim overgrowth on the banks, so you could fish all day on the Day Permit, or all week on the 7 Day Permit, or, All Season 12 Months Permit. By the way, there was another river, the Hampshire Avon just as close as a bike ride with equipment, but it was constantly altered and played with by the Water Board. Hence not as nice as the natural Stour.

There were mainly two methods of fishing - ledgering, using a lead weight or swim feeder on the bottom, or trotting. Trotting was float fishing between the banks of weed or swims as the angler would term it. The bait was always maggots (white), then someone started dyeing them. Now there is something strange about anything that's dyed that's not naturally that colour (peoples hair for one). Now, a blue maggot is strange, and red, yellow, green, all sorts - sounds like liquorice. The only thing about the dyes they used was that after a day's fishing using, say, yellow maggots, your hands were yellow. You could scrub and scrub but no way you could move the colour, so people would see your hands and assume how the colour got there (double handed smoker?). Blue was interesting too.

There is something quiet and relaxing about sitting by a river flowing past at a constant speed, weed waving in the current, birds singing on a lovely long English summer's day - well, it used to happen (English summer days that is). You would be so quiet that water rats would appear, moles would push up a mole hill, voles, harvest mice, ducks, swans (white), moor hens. Everything would appear so close. One day while I was eating my sandwich, a very small shrew climbed into my empty lunchbox to eat the crumbs. It was another world.

I don't miss too many things about England - parents, driving through the New Forest with the roof down in my MG from pub to pub on a summer's evening; fishing on the Stour Throop Fishery. Simple things - DON'T TELL MY PARENTS!

PS Fish were caught and released. That's course fishing - minnows, gudgeon, eels, dace, chubb, barble, pike, trout and salmon.

PPS And that this how and why I fish with the rod in my right hand and reel with my left hand. Nothing to do with being right or left handed - amazing!

### **Recreational fishers declare war on 'Aquatic apartheid'**

Recfishwest has declared war on what it calls 'aquatic apartheid'. Recfishwest says that it has had enough of the government's irresponsible planning process for marine parks.

Recfishwest feels cheated by a process which specifically targets recreational fishing but which excludes them from reasonable input into the development of the plans.

Executive Director of Recfishwest, Frank Prokop said. "While the marine planning process in Western Australia is not racially motivated, it seeks to segregate the users of the aquatic environment, condemning recreational fishers to the poorest areas in a similar unfair way."

Recfishwest had been previously disgusted at the gross injustices regarding among other issues the lack of recreation zones in the Jurien Bay Marine Park. However more recent processes have been even worse.

There is a proposal to exclude recreational fishers from 95% of the inshore fishing areas at the Rowley Shoals with absolutely no consultation with groups such as Recfishwest. When Recfishwest queried this, we were told it was because one dive charter operator didn't see any of the already protected hump-headed Maori wrasse on one day.

Recfishwest's submission on Rowley Shoals has not even been acknowledged yet we believe that the park is about to be declared.

"The government is clearly hoping that Rowley Shoals is too far away for it to worry about community accountability. The plan they have proposed will be extremely expensive for compliance and CALM have no credibility in this regard with the community." Mr Prokop said.

Recfishwest claims that Ningaloo is an even bigger disaster. "We believe that the proposed northern extension to the Ningaloo Marine Park, to include the Murion Islands as a Marine Management Area, cannot include sanctuary zones as have been proposed. The New Horizons document clearly states that a marine management area cannot exclude activities including recreational fishing."

The irony is that the Fisheries Department already has a protected area at South Muiron Island which would either have to be excised from the marine management area or revoked.

"This clearly demonstrates that Fisheries legislation is the most suitable for managing the aquatic resources of this state. The Fisheries Department has also shown a willingness to work with fishing interests rather than continually attacking them and their activities." Mr Prokop said.

In Ningaloo there are sanctuary zone proposals that ban fishing to allow exclusive access to snorkellers.

"I ask you, which is likely to damage the environment more, an angler drifting a bait through the area or a dive boat that has to drop an anchor on the delicate coral?"

Recreational fishing is under attack in the Dampier Archipelago, Rowley Shoals, Ningaloo and the Cape to Cape region. Recfishwest has joined with the commercial fishing industry to express concerns about the Cape to Cape planning process.

"It is clear to us that the Premier is getting very poor advice on the extent of community outrage over the discrimination against recreational fishers in the marine parks planning process. The Premier was quick to squash the irresponsible Rottnest Island sanctuary zone proposals but does not see that the CALM processes are even more discriminatory."

Recfishwest is calling on all recreational fishers to let the Premier know that it is essential that marine parks that have community support include adequate involvement of recreational fishers. Otherwise recreational fishers will become extinct in Western Australia.

### **My personal email to the Premier.**

Similar ones were sent to the other Ministers, adapted for their portfolios.

Dear Dr Gallop.

I am sending this email to you because of my concerns about the process for deciding Marine Parks in WA.

Please be assured I support the need to protect our valuable environment, but it is unscientific to exclude recreational fishing when there is no evidence to show it is causing any loss of biodiversity.

I believe you are getting poor advice about the consultation process, for the Ningaloo Marine Park in particular. For most of the Marine Park proposals which have been out for public comment so far, the consultation has been measured by length of elapsed time and numbers of submissions, etc, but NOT by how much notice was taken of what was said, and that needs to change.

I also believe that you are getting very poor advice on the extent of community outrage over the discrimination against recreational fishers in the marine parks planning process.

You were quick to squash the poorly thought out and unjustified proposals for sanctuary zones on Rottnest Island, and I thank you for that.

But I believe that the CALM and MPRA Marine Park processes and some outcomes are equally unjustified, yet you are perceived as supporting them.

I perceive that you and your government are pushing some of the recent ones, eg Ningaloo, as finalised Government environmental achievements despite some still being out for public comments.

I observed your Environment Minister state quote "We have saved Ningaloo" without any extra comments or qualifications on what that means or what Ningaloo was saved from.

You would be well aware that your Department of Fisheries is rightly world renowned for their progressive approach to sustainable management of fish stock and habitat.

The tight restrictions already placed on recreational fishers are ensuring sustainability of fish stocks and have been embraced by the majority of fishers statewide through fair and equitable consultation.

Integrated Fisheries Management should further strengthen that management of the recreational catch component.

It is unfair to place the majority of restrictions in Ningaloo on recreational fishers considering there is no evidence to show any threat to fish stocks or biodiversity by fishing in the marine park.

CALM and MPRA steadfastly refuse to acknowledge the role and the work of the Department of Fisheries in managing fish stocks as part of the management of biodiversity.

CALM and MPRA continue to push for allowing no impact at all under the guise of "preserving biodiversity". They will not acknowledge sustainable practices but insist that areas must be closed completely.

CALM and MPRA have high percentage targets for closed areas based on what is claimed to be necessary in other parts of the world which have unsustainable, damaging and destructive practices and uncontrolled fishing. There is no evidence that these requirements apply to the totally different situation in Western Australia with our excellent environmental and fisheries management.

CALM and MPRA have no answer to the question "if significant percentages of some areas are closed to recreational and commercial fishing, how do they propose to address the fact that the pressure on the areas which are not closed will be increased and lead to more degradation if their claim of overfishing is true?"

Failure to answer this question shows the extreme lack of science and practicality in their approach of relying on no take zones as the sole means of preserving biodiversity.

Mr Premier, you will be aware that the Environmental Policy Unit in your own Department of the Premier and Cabinet is currently drafting a paper on Bioregional Marine Planning which states "Many people in the community agree that a more integrated, ecosystem based approach to planning and management of our marine and coastal environments is needed and there is general agreement with the need to adopt a bioregional marine planning approach."

This initiative, which I welcome, acknowledges that the current process has weaknesses. Proposals made under the current process also have weaknesses, which means no proposals made under the current system should be implemented until the Bioregional Marine Planning approach is finalised and proposals checked against that process.

It is essential that planning for marine parks include adequate involvement of recreational fishers for the parks to get community support.

I ask you to reconsider your stance on Marine Park planning, and in particularly on Ningaloo.

## **Sport Fishing**

An article designed to get you thinking, not drop a bomb in.

Ask yourself this very important question. Are you a 'sport fisherman' or do you catch much more than you need?

Some people say that "I only want to catch a feed" then proceed to catch more than they really need for that purpose.

If your answer is the first response then you may as well put this article down and go fishing, as you obviously understand where I will be coming from.

If however, your answer is in the second response, then it is seriously time you started thinking about what you are doing.

Today we are more then ever looking at our future in the fishing scene. Already on the east coast of our country greenies are interfering with the Club sport of angling. It won't be long, with every greenie looking over our shoulders at what we are doing here, before we are also confronted. It is high time we started setting an example that our children and their children will be proud of.

This article is covering what the club uses for its competitions. Whatever fish you catch and keep during the Field Day for your own use and don't enter in the Club competition is your own business.

We don't have to kill every fish we count in our club competitions!

Many other fishing competitions around the world either weigh in live fish or fishes 'catch and release' and penalises competitors with dead fish.

It is high time we, as a club, started doing something similar, or at least releasing most of the catch counted in the competitions back into the water for future generations to enjoy as much as ourselves.

You may now say, "but we have catch and release already". Yes. So we do. But who amongst you even thinks about it when we have a field day. Who amongst you has asked for a 'catch & release form' at sign on for a field day? Indeed, who amongst you has actually seen a Club catch and release form?

Some of the more senior members have put forward "Its hard. You can't make it equal for everyone to weigh in and get the points they deserve for the fish they caught". "We need a sub-committee to decide which way we are going to score catch and release". "You can't weigh in rays/wobbegongs/etc." "They aren't on the 'species list'."

How long is it going to take to see that some potential members may be turned away with this attitude? Some potential members have turned away because of this attitude put forward to them. Some people who have been members at our club have left citing similar excuses for leaving. "The club is too set in its old ways". "They don't want to change". "They can't see the need to change".

A simple form for catch and release need merely show the species and the length to confirm a point's allocation for the competition. Currently, we are over emphasising the weight factor for all our field days. Weight is the major consideration for all records. OK. Lets include the weight, but weigh the fish when caught and return it to the water. It is not that difficult to obtain a set of scales that will do the job quickly and accurately.

A simple solution could be as follows. All fish caught must be sighted by a fellow club member and authenticated by a signature on the catch and release document, signifying that the fish has been sighted/measured/weighed and released alive back into the water. This would enhance a major component of our club. Camaraderie. We would no longer have people fishing by themselves. This would also enhance broadening of fishing knowledge as people teamed up with others in order for their verification signatures. It may even promote more attendance at our field days in that those wanting to go will have to arrange another member to verify their catch.

The point scoring could be along the lines of 'X' points per non edible or non-specific species and 1 point per cm or even 1 point per 10 cm. For edible species, or designated favourite species, an allocation of perhaps '2X', '5X' or even '10X' points per species plus a point per centimetre as for non-edibles. The competition could also specify that only one of each species be permitted for weighing in, as currently the AAA Boating Section utilises.

Weight need not be a consideration, but could be included in some format for records.

The inclusion of currently banned species (rays/wobbegongs, etc.) could then be re-introduced. As a sport fish, most rays put on a dam better fight than most currently caught species on our list of eligible catches.

By releasing most fish caught, would turn our monthly Club Field Day competitions into the sport that it needs to be seen as. There is no problem keeping enough for a meal for the family.

Some people would be in disagreement at this time. 'What about line ratio badges?' What about masters badges, species badges, and so the argument goes on.

Yes twenty years ago these things were all well and good. However, in today's society 'catch and release' needs to be incorporated. If as a Club we still want these 'badges' why not merely change the specifications for earning them from a weight factor to a points factor. If a weight factor must be retained, then let another member verify the 'bona-fides' of the catch with his signature on a catch & release form.

At this point in time a few brains may have been stimulated into consideration of changing from the old ways.

Think about change. It might help us to stay alive and prosper as a Club.

Some of you will no doubt remember some proposals like that - they go through pretty quickly and most people are happy with the result.

(2) a person gets an idea, but the details aren't enough to turn it into a possible set of rules. Then someone (eg a sub-committee) takes over and does all the details as listed in (1)

## **What's in that Greenough River Estuary?**

With the Field Day up that way on the Long Week End in October, here's a topical warning in a Media release from Department of Environment on 20 September.

### **More fish deaths reported in the Greenough River Estuary.**

The Department of Environment and Department of Fisheries are continuing efforts to determine the cause of a major fish kill in the Greenough River Estuary. Last week the Department of Environment reported about 50 dead fish had been found on September 8 and 9.

Mid West Gascoyne Regional Manager Ron Shepherd said since that time, the number of dead fish had increased to more than 5,000 mature fish and thousands of fingerlings, totalling about 3,500 kilograms in weight.

"Although the majority of the dead fish in recent days have been mullet, numerous other species including estuary cod, cobbler, mangrove jack and perch - and hardy fish like bony herring and bartailed grunners - have also died," Mr Shepherd said. "A significant mulloway estimated at 60 kilograms was also found.

"The water has had a khaki-green colour to it recently, suggesting an algal bloom has developed following rains received several weeks ago. "Potential fish-killing algae have been detected in water samples collected on September 13, but the significance of this is unknown.

"The presence and numbers of these species need to be compared to fish pathology results, which are underway, to confirm the cause of death.

"Preliminary pathology results suggest bacteria are not responsible for the fish kill, and that it could instead have been caused by toxic algae, but further testing is occurring to confirm this. "We will inform the community of the cause as soon as it becomes clear, but in the meantime people and their pets should not touch or consume any fish from the river. We would also advise that fishermen do not fish while this kill is occurring to give stocks a chance to recover.

"The department also acknowledges the Shire of Greenough for its efforts in clearing the river of dead fish."

An earlier media release in July said "First reports of a fish kill were received on July 14 and 15 and indicated the deaths of about a dozen large sea mullet. Mid West Gascoyne Waterways officer Mike Johnson said in the two weeks since the reports were received approximately another one hundred and fifty mullet ranging in size from 20 to 40 centimetres had died. He also said one reasonable sized estuary cod was also found dead.

"Results from fish pathology tests have indicated multiple possible causes of death, although there is nothing definitive at this stage," Mr Johnson said. "However, tests showed strong evidence of parasites, high levels of bacteria and poor water quality in a localised area may have contributed to the fish deaths. "The affected fish had not been feeding, their gills were ragged and there was evidence of cell response to hypersalinity.

Mr Johnson said water samples indicated low to moderate levels of the algae *Karlodinium micrum*, a known fish killing species. "The Fisheries department are still testing for other diseases in the fish," he said.

Mr Johnson said there wasn't a complete level of understanding of the water quality cycle in estuaries like the Greenough, a system that only opens to the ocean every few years.

"Consequently, we also don't know how this complex cycle affects the fish living in them," he said. "We advise that people and their pets should avoid touching or eating the dead fish in the Greenough estuary.

Postings on the Western Angler Fishing Forum had some more information.

The 60kg mulloway (weighed) was estimated at around 2m long. There weren't pictures of the monster, but apparently the size estimate is pretty reliable. There was a picture of a "smaller" mulloway found dead with a girth of around 1.2m and a bit longer than a 240 litre wheelie bin.

The locals up there reckon when the river breaks through GIANT UNSTOPPABLE mulloway hound the bait fish in the shallows. Thinks it would be a pretty good environment for the mulloway to grow, no predators and plenty of food.

Bryn Farmer, researcher from Centre for Fish and Fisheries Research at Murdoch University 9360 2256 mob: 0400 213362 is doing research on mulloway (and he would always welcome fish frames), believes the smaller fish would probably be around 35 years old, and 50+ years for the 60kg individual.

For his research he's been trying to organise the collection of mulloway from the area as they have been dying. Greenough council has been very helpful though and even tried to organise for the larger fish to be dug up from the local tip! Unfortunately, the large fish were buried with medical waste, covered with a ton of soil and crushed down with a 14 ton press! Needless to say, they wouldn't be in good shape... It is a great shame, as that big fish would have been invaluable to science.
